# 店舖因售賣假鱷魚肉被重罰

本會於去年11月發表鱷魚肉測試結果，發現24個樣本中，有16個樣本並非鱷魚，而是巨蜥或蛇。此外，8個含鱷魚肉的試驗樣本中，有1個攙雜了蛇肉。本會將結果交予香港海關和漁農自然護理署（漁護署）跟進，近日有涉嫌售賣假鱷魚肉者先後被判罰或正待審訊。

## 海關「放蛇」行動搜集樣本

去年9月，海關首先根據本會所提供的資料採取「放蛇」行動，喬裝顧客試購樣本給政府化驗所作DNA分析，展開打擊懷疑售賣假鱷魚肉乾的活動。

之後，海關根據化驗結果，於去年11月12日聯同漁護署，向涉嫌售賣訛稱是鱷魚肉但實際是冒充貨品，及在沒有許可證下售賣受保護動物的店舖採取聯合行動。海關和漁護署人員突擊搜查7間涉嫌將水

的店舖，在其中3間店舖一共檢獲14.75斤有問題鱷魚肉乾，並送交政府化驗所化驗。化驗後證實所檢獲的肉乾主要是巨蜥肉及蛇肉。行動中拘捕的3男1女，事後獲准保釋候查。

## 已有商號及有關人士被罰款

有關的店舖及被捕男女最終被檢控觸犯《商品說明條例》，售賣及管有已附有虛假商品說明的貨品作商業用途。其中5間店舖、店東或售貨員於今年4月至7月期間，各被判罰款由\$1,000至\$30,000不等，餘下

2間店舖的檢控案件已安排於9月初在法院進行答辯或審訊。

- ◆ 購買鱷魚肉時，要選擇商譽較佳的商舖；
- ◆ 可向售賣鱷魚肉的店舖查看是否領有有效的許可證（見附圖）；
